3. Agenda and Notes, Decisions, Issues

Topic	Discussion
Review January 9, 2012 Minutes	The minutes from the January 9, 2012 council meeting were reviewed and action items were discussed. Action item #1 was reported as complete with MDA having provided conflict of interest guidelines to the Council. Action item #2 was also reported as complete and reverted funding information was provided for the Council. Dan Dobler suggested that the reverted funds and additional information sheets be provided to the Council prior to the grant hearings. Action item #3 was discussed and Dave Burch reported that he will follow up with Steve Shelly on Forest Service funding for inspection check stations. Margie Edsall moved to approve the minutes as written. Nico Cantalupo seconded the motion, which was approved unanimously.
Budget Review	<p>Greg Ames reviewed the MDA Weed Program budget and reported \$2,132,158 as the estimated program revenue for fiscal year (FY) 2012. Program expenses for FY 12, including Special County / Reservation grant awards, Montana Department of Transportation (MDT) pass through county funding, reverted funds transfer to the trust fund principal, the cash balance adjustment, and program operating expenses were estimated to total \$1,330,999. Greg advised the Council that \$801,159 was available from State Special Revenue and General Fund dollars for FY 12 grant awards.</p> <p>Grant funding from the US Forest Service State and Private Forestry was discussed with Greg reporting an initial award to the MDA of \$605,000 and an additional award of \$60,000 that was specified for tribal projects. Dave Burch said that applications had been expected from the Crow and Blackfeet Tribes to utilize a portion of the tribal funds, but to date applications had not been received.</p> <p>Greg reported that the MDA grant application to the Forest Service specified awards of \$40,000 to the Missouri River Watershed Coalition project (MDA 2012-701) and \$40,000 for the Weed Free Borders project (MDA 2012-702). Additionally, \$18,150 was designated for program operations, which included expenses for a summer intern, and \$18,840 for MDA Central Services indirect costs. Forest Service funding to be awarded at the 2012 hearings was reported at \$548,010.</p> <p>The combined total available for award at the hearings was reported as \$1,349,169. Applications received for consideration at the hearings totaled \$2,853,889, leaving a shortfall of \$1,504,720.</p> <p>Mike Miller asked for clarification on the MDT pass through funding. Dave Burch said these funds are passed through MDA to the counties to be used to enhance the weed control program in the county, specific use of the funds is not provided to the Department.</p>

<p>Hearing Protocol, Other Business, Public Comment, WebGrants Review</p>	<p>Hearing protocol was reviewed followed by Ron de Yong asking if there was other business to discuss. Discussion followed regarding the submitted applications meeting trust fund requirements, division of funds among education, research, and local cooperative projects, and the possible need for changes to evaluation criteria. Greg Ames encouraged the Council to complete application evaluations and funding recommendations based on the merit of the project. Dave Burch noted that the evaluation criteria was based on language from the Noxious Weed Trust Fund Act and urged the Council to score projects based on their perception of the quality of the project. The Council was advised that if needed, changes could be made to the evaluation criteria by a rule change and encouraged Council input. Steve Siegelin suggested utilizing statements rather than questions in the evaluation criteria. Mike Miller suggested that the evaluation forms have a section to designate the reviewers funding recommendation as “full, partial, or none.” Several Council members said it would be helpful if a report was provided for the reviewers with key information from their reviews.</p> <p>Greg Ames suggested a criteria committee be formed to assess what evaluation changes might be needed. Greg encouraged Jim Story to head up the committee with Jim Olivarez and Steve Siegelin.</p> <p>Ron de Yong asked for public comment. None was heard.</p> <p>Discussion turned to the education and awareness program that had been housed at Montana State University (MSU) and options for continuing a coordinated education program. Dave Burch provided background information regarding the MSU project proposal that was submitted earlier, which had not been accepted by the Council. Due to timing deadlines, MSU had not been able to submit an application for consideration at the 2012 grant hearings. Ron advised the Council that the MDA hoped to provide an option to continue the education program with the submittal of the MDA 2012 grant proposal. Concern with trust fund dollars funding the full time salary for an education coordinator was discussed. However, others noted that the program may die if there is not an option to carry the program through this year.</p> <p>Dave Burch discussed the funding sources that have supported the Statewide Awareness and Education program in past years, reporting that currently committed funding included \$25,000 from the Bureau of Land Management (BLM), \$15,000 from the US Forest Service, and \$15,000 from MDT. Mike Miller suggested financial contributions from counties and agencies to increase the participation and buy in to the program. Tracy Sterling advised the Council that MSU is committed to the project and that Jane Mangold is currently involved in the program with MSU. Questions were raised about the future of the project and where the staff would be housed. Ron de Yong noted that the program is in a transition phase and said he hoped for greater involvement from the Extension Service in the future.</p> <p>A review of the WebGrants system that the Council will use during the grant hearings and deliberations was provided by MDA staff. Monday hearings began at 2:00 p.m. and concluded at 5:00 p.m. Public comment was asked for and none was heard. Tuesday hearings began at 8:00 a.m. and concluded at 5:00 p.m. There was no public comment. Wednesday hearings began at 8:00 a.m. and concluded at 5:45 p.m. There was no public comment. Thursday hearings began at 8:00 a.m. and concluded at 3:30 p.m. The Council agreed to begin deliberations Friday morning. There was no public comment.</p>
<p>Re-open Meeting for Grant Award Deliberations</p>	<p>The Council reconvened at 8:00 a.m. on Friday, March 2. Greg Ames noted that this was the last grant hearing session for Dan Jackson as his term on the Noxious Weed Management Advisory Council would end June 30, 2012. Dan was thanked for his work and dedication to the Council.</p> <p>Dave Burch asked for Council input on application T12-039, the Sapphire Village project. Dave explained that although this project had been submitted by Fergus County, the project area was in Judith Basin County. Due to Judith Basin County not having met the 1.6 mil levy or class one county requirement, they had not received a Special County / Reservation Grant in fiscal year 2012. Dave was waiting for clarification from the MDA attorney regarding the funding eligibility of projects in Judith Basin at this time. Dave received word from Cort Jensen, MDA attorney, that the Council should base their funding decision on the merit of the project. Kim Johnson contacted the Judith Basin County Treasurer who stated that they now met the 1.6 mil levy requirement.</p> <p>Greg Ames advised the Council that applications would be deliberated on in the order of the highest average review scores given by the voting members of the Council. Discussion followed and Jack Eddie asked that all applications be discussed and deliberated.</p> <p>Robert’s Rules of Order, conflict of interest, and deliberation protocol and procedures were reviewed. Greg advised the Council that he would serve as Director de Yong’s proxy vote in the event of a tie vote when the Director was not in attendance. Donna Rise was asked to continue this discussion with Director de Yong and discuss quarantine procedures with Cort Jensen. Donna was asked to report back to the Council.</p> <p>As the deliberations progressed, the Council discussed how to proceed in deliberating the lower ranked applications. The majority of the Council members favored continuing to deliberate on each application. Deliberations continued in sequence of the application rankings until reaching T12-087. Jim Gordon moved that due to lack of funding and low rankings by the Council, that the remaining applications, number T12-087, T12-075, T12-019, T12-092, T12-020, T12-003, T12-041, T12-102, T12-079, T12-078, T12-044, T12-043, T12-093, T12-095, T12-047, and T12-094 be funded at zero dollars. The motion was seconded by Jack Eddie. Discussion followed with Margie Edsall requesting that the applications with high rankings from agency representatives be heard. Jim Olivarez noted the importance of applications T12-075 and T12-078 and requested an amendment to Jim Gordon's motion. Jim Gordon was not in agreement with the proposed amendment for T12-078. The proposed amendment was not seconded. A vote was taken on the motion made by Jim Gordon. The motion passed with all voting members, other than Jim Olivarez, in favor of the motion. The motion passed by a majority.</p> <p>At this point grant award recommendations were reported by Dave Burch as totaling \$38,730 more than the available funding. Deliberations continued with re-opening of several projects, including T12-075, which was then funded for \$10,000. Jim Olivarez moved to re-open T12-079 and was seconded by Dan Jackson. Discussion followed and Jim Olivarez withdrew his motion due to realizing a conflict of interest. Additional projects were re-opened and discussed until adjustments were made to remove the funding deficit.</p> <p>The Council discussed projects to be considered for additional funding if unexpected revenue became available. Following discussion, Dan Jackson moved that if additional revenue for grant funding is available, that it be used to fund the next available project in the priority order that they have been ranked, at Director de Yong's discretion. The motion was seconded by Jim Story and unanimously approved.</p>
